Installation of biomass boiler plant and wood fuel integrated storage with adjacent fenced enclosure containing a new oil storage tank and the school recycling bins, which will be moved from their current location. The existing oil storage tank and its supporting brickwork will be removed. The end section of the wall adjacent to the driveway, furthest away from the entrance, will be removed and replaced by a metal vehicle barrier.

The rating of the boiler has changed from 60kW to 65kW, as the previously planned boiler is no longer available, since it has been upgraded to an improved model. The plant room is remaining the same size, so there will be no external change to the appearance. The boiler modulates (varies in accordance with the school heat load) and the boiler will also be turned on and off in accordance with when heat is required. Therefore, given the design concept is for the biomass boiler to provide all the space heating for the school, the 65kW boiler will be providing no more heat to the school than the 60kW boiler would have done.
